# **INTERNATIONAL ORIGINAL PRINT EXHIBITION 2025**

The International Original Print Exhibition, established by the Royal Society of Painter-Printmakers (RE), is an international open submission exhibition celebrating the best of contemporary printmaking. As an art organisation run by artists, the RE is constantly working to create long-term opportunities for artists and promote printmaking to a wider audience.

Works selected will be exhibited at Bankside Gallery from 6 – 16 November 2025. Bankside Gallery is situated next to Tate Modern, in the heart of London's newest cultural quarter.

## Entry

Artists may submit up to 6 recent prints for a <u>non-refundable</u> fee of £16 per picture. Students in full-time education (ID required) can submit up to 6 recent prints for £12 per picture.

Entries must be submitted digitally via our online system. These digital submissions are assessed by a panel of judges who can select up to a maximum of 3 artworks for any one artist. The judges' decision is final.

To submit your work, you will be redirected to our new online entry system on Zealous. If you have not used this system before you will be asked to create an account. This will allow you to check back in to your submission after you have entered. Please be aware the name that you use to create this account will be how your name will appear if selected for the exhibition. The email address used in your profile set up will be used to notify you about your submission. Please ensure this email address is entered correctly or you may miss important notifications.

The system will ask you first to make payment - you can pay at this stage for multiple entries, but you can always come back and add more. You will then be asked to submit one image and all the details for your first entry before uploading the information and image for any subsequent works.

During the entry process you will be asked for

- An image of each artwork Make sure this is of a good quality, size 1-3MB as a guide, cropped to the edge of your work image
- Artist's name (exactly as you wish to be known on the works list and labels)
- Contact email address for the artist (please be sure to spell this correctly!)
- Title of the work
- Framed dimensions in centimetres
- Medium
- Framed price for each print

Remember to take into account framing and transport costs, as well as Bankside Gallery's commission of 45% should the work sell. If you are registered for VAT, please include this in your price.

No changes to your price(s) will be possible after the competition deadline so please ensure they are correct.

- **Unframed price for each print** (only if applicable ie. Do not fill in this field if further prints in the edition are not available or if it is a monoprint / monotype)
- Availability of further unframed prints in the edition (if applicable)

Students <u>will be required to show student ID when delivering the work to the drop-off location</u>. When submitting student work online, please <u>also</u> scan your student ID and email a copy to info@re-printmakers.com. Any works found to be falsely submitted as student work will not be hung.

Make sure you complete and pay for your entry – incomplete entries will not be shown to the Selectors.

# Eligibility

- Any forms of original printmaking are eligible. Reproduction prints are not accepted.
- All artwork must have been made in the past 3 years, dating from 1 July 2022
- Work must not have been exhibited in an RE open submission exhibition before (ie. International Original Print Exhibition or Small But Mighty)

- There are no limitations on style or subject matter
- Artists from any country may enter provided they are willing and able to get their work to and from the designated drop off and collection venues at their own cost
- The work must have been made by the entrant
- All work must be for sale
- Artists must be 18 or over on 1 July 2025

# Results

A list of prints selected for the exhibition will be published on <u>www.re-printmakers.com/international-original-print-</u> <u>exhibition</u> by 6pm on Friday 12 September. Artists whose work has been selected will be sent an email confirming arrangements for the exhibition. <u>Please check your junk mail at this time to avoid missing this notification</u>. We will try to contact all artists whether successful or not, but given the large volume of applicants we ask you for your patience in waiting to hear from us. Checking whether your work appears on the list of selected prints will be the quickest way for you to find out the result of the competition.

Please be aware if your work is successfully selected for the competition your first name, surname and name of selected work will be published on our website in a public domain. We will not publish your email address.

#### General Data Protection Regulations (GDPR)

New data protection laws came into force on 25 May 2018. As an entrant to the competition you give us your first name, surname, email address, postal address and telephone number. We do not receive your payment card details as these go through the GDPR compliant online payment system. Please be assured we take keeping your data safe very seriously. You can read our updated Privacy Policy on <u>banksidegallery.com/privacypolicy</u>. In order to inform you about the results of the competition judging, we need to be able to contact you using the email address you have provided us with so that we can carry out the service you are paying us to do. This is our legal basis for storing your contact details until you tell us not to. However, in order to keep you informed about future competitions administrated by Bankside Gallery which may interest you, we would like to send you some occasional direct marketing in relation to this topic and the Royal Society of Painter-Printmakers. Please tick the opt-in box after writing your contact details when you enter this competition online in order for us to do so.

# Preparing Your Work for the Exhibition

# An exhibition of the selected prints will be held at Bankside Gallery from: Thursday 6 – Sunday 16 November 2025.

- There are no size restrictions on works you can submit. However, artists with extremely large works are advised to
  contact Bankside Gallery to discuss details prior to submitting.
- Poorly presented prints or works that differ significantly from the photograph that was entered will not be accepted.
- For your work to be insured against theft under Bankside Gallery insurance, your prints must be framed, glazed and fitted with mirror plates. <u>Other display options are accepted, BUT:</u>
- a) there must be a compelling reason for the work to be displayed unframed
- b) work must be displayed in a way that is suitable for a professional gallery setting
- c) the alternative hanging method must be appropriate to the work
- d) you must provide all equipment for this hanging, eg, clips, magnets, shelves etc and clear instructions on the hanging of your work
- e) you must provide a safe and secure way in which the work can be safely stored, and also wrapped and protec ted if sold.
- f) you display these works at your own risk
- Please note -

The entry system asks for a framed price as a mandatory field. If this is not applicable to your work, enter '0' in the se fields but then you MUST complete the image size fields instead. Works with no dimensions will not be selected as we require size information to inform this decision.

#### Framing

- Frames must be of a professional quality. No clip frames or metal frames will be accepted.
- Artists are responsible for costs involved with rectifying defective frames or mounting of works in the case of customer complaints regarding sold works for up to 12 months after date of sale.

#### Mirror-plates

 Framed prints must be supplied with mirror-plates (pictured) screwed to each side of the frame with a pair of screws half way down from the top of the frame. Bubble wrap or card wrapped around the mirror-plates should prevent damage during transit.



All works are to be handed in unwrapped and will be transported in blankets. All works
will be handed out unwrapped so artists will need to bring their own wrapping when they
collect their work.

#### Labels

- You will receive labels for your framed works via email if informed that your print has been accepted. Please fill
  out the information with the <u>SAME</u> details of your name and title of work that you submitted online, and fix one to
  the front and one to the back of your work. This is so we can identify the work when it is screwed to the wall and
  label it correctly.
- The label on the back should be fitted securely.
- Please make sure the label on the front can be easily removed without leaving a sticky residue. A small piece of masking tape or Scotch "Magic Tape" (pictured) is the best option for this. No sellotape or sticky labels please.

#### Insurance

The prints remain at all times the liability of the artist. While every care
will be taken when handling artworks neither Bankside Gallery, nor the
RE, can accept liability for any damage.



 You may wish to insure your work against loss or damage while it is in transit or at the Bankside Gallery. Prints selected for exhibition will ONLY be insured at the venue (Bankside Gallery) throughout the duration of the exhibition, and once they are screwed to the wall with mirror-plates.

#### Copyright

The copyright of all works remains vested in the artist, but the right is reserved for Bankside Gallery and/or the sponsors of the exhibition to reproduce any of the prints in connection with the exhibition, and its publicity, free of charge. Any other enquiries regarding copyright will be referred to the artist.

## **Delivering Your Prints**

#### **UK ARTISTS:**

Selected works are to be delivered to Ground Floor, 23 Blue Anchor Lane, Bermondsey, London SE16 3UL on Friday 31 October or Saturday 1 November 11am – 5pm. <u>No works will be accepted at Bankside Gallery</u>.

- Bermondsey is the nearest tube station (Jubilee Line) and 10 minutes walking distance to 23 Blue Anchor Lane.
   Parking is free on Blue Anchor Lane, but not plentiful. There is also a National Rail Station at South Bermondsey, which is serviced by Southern. Check www.tfl.gov.uk for maps, buses and travel updates.
- You will be asked to unwrap your prints and <u>take any packing material away</u> with you.
- If you are planning to use an art courier to deliver your prints, we recommend: Picture Post (info@picturepostcompany.co.uk / 07833 450 788) Art Moves of Chelsea (artmoveschelsea@aol.com / 020 7352 7492)
- Work will not be accepted if delivered by taxi, Royal Mail, FedEx, DHL etc., as 23 Blue Anchor Lane do not have specialist art insurance, nor can they unwrap works and remove packaging. Artworks delivered in this way directly to 23 Blue Anchor Lane will not be hung in the exhibition and will be disposed of immediately. There can be no exceptions to this rule. Please liaise with Picture Post who can receive works from non-art couriers and then deliver it to Bankside Gallery for an additional fee. No work will be accepted if delivered to Bankside Gallery directly from the artist/artist's representative.

#### **INTERNATIONAL ARTISTS:**

Please liaise with Sarah & Tom at Picture Post (info@picturepostcompany.co.uk / 07833 450 788) who will:

- Assist with the VAT process.
- Receive artwork from DHL/FedEx/TNT etc.

- Hand in on the due day.
- Store the packaging for use in the event of a return being required.
- Collect unsold or unaccepted artwork.
- Repack.
- Arrange the export service.
- Picture Post can provide schedules and prices for receiving your work from abroad and delivering it to Bankside Gallery. This is **not** a service that Bankside Gallery can offer.
- Work will not be accepted if delivered by taxi, Royal Mail, FedEx, DHL etc., as 23 Blue Anchor Lane and Bankside Gallery do not have specialist art insurance, nor can they unwrap works and remove packaging. Artworks delivered in this way directly to 23 Blue Anchor Lane or Bankside Gallery will not be hung in the exhibition and will be disposed of immediately. There can be no exceptions to this rule. Please liaise with Picture Post who can receive works from non-art couriers and then deliver the work to Bankside Gallery for an additional fee. No work will be accepted if delivered to Bankside Gallery directly from the artist/artist's representative.
- Artists are advised to get in touch with Picture Post as soon as possible. The hand in dates are for work arriving to the gallery rather than the date to arrive with Picture Post. Please also bear in mind, due to Brexit there have been long delays in Customs, so artists may need to send works earlier than they normally would. Plus, there is now the potential of Customs Charges for artists in the EU.

### Sale of Prints

- All prints entered in the competition must be available for sale. Sales and payment will be handled by Bankside Gallery who charge a commission of 45% on picture sales. All works will be sold as seen, so your selling price should take into account the commission, and the framing and transport costs you will have incurred.
- If you are VAT registered, please give the full retail price inclusive of VAT.
- International artists should also take into account they will be responsible for paying any international bank transfer fees incurred by Bankside Gallery in transferring their payments to them. Any fees incurred will be deducted from the total amount due to the artist in the event of a sale of their work.
- Artists will be notified of sales by email shortly after they occur and will receive the balance due within six weeks of the end of the exhibition.

#### **Shipping Policy**

- Bankside Gallery cannot store unframed editions of your prints during the exhibition. If a customer wishes to
  purchase an unframed version of the framed print in the exhibition, we will process this sale as a 'print order' and
  you will be emailed a copy of the receipted invoice detailing where to post the print.
- Bankside Gallery will not charge buyers for postage and packaging of unframed prints sent within the UK. <u>This</u> <u>P&P cost will be the artist's responsibility</u> so please ensure your unframed price allows for this.
- Bankside Gallery will charge the customer up to £30 for posting an unframed print to Europe. This additional amount will be passed onto the artist to cover postage and packaging costs.
- Bankside Gallery will negotiate an additional charge with the customer to cover international (outside of Europe)
  postage and packaging of an unframed print. The amount will vary depending on the size of work, where it is going
  and whether it is being sent rolled or flat. This additional money will be passed on to the artist to cover costs.
- Bankside Gallery will initiate shipping arrangements for the buyers of a framed piece from the International Original Print Exhibition to its destination, but then it will be between the buyer and the shipping company. The cost of this will be the buyer's responsibility.

**Collecting Unsold Prints** 

#### UK ARTISTS:

 If you have not been notified of a sale during the exhibition you must collect your unsold work from Bankside Gallery on Sunday 16 November, 6 – 8pm, or Monday 17 November 11am – 5pm. Please bring photo ID so we release the artwork to the right person. Please also bring wrapping material, as this cannot be provided.

#### **INTERNATIONAL ARTISTS:**

- Please see the information regarding Picture Post's service under 'Delivery of Works' above.
- Bankside Gallery is unable to pack and send work back to the artist.

#### **Uncollected Prints**

- Artworks left at the Gallery after 6pm on Monday 17 November will be removed by Art Moves of Chelsea. You should contact them on 020 7352 7492 to make an appointment to collect your work, but you will have to pay their storage fee of £20 per work, for the first week (part or whole) before the work is released from Art Moves of Chelsea, Nationwide Self Storage, Blantyre Street, Chelsea, London SW10 0EQ. The cost increases by £5 per week. Work not collected within one month from Art Moves will be disposed of.
- If you are unable to come to Bankside Gallery yourself, you may send a representative or engage a professional art courier. They should bring a signed letter from you authorising us to release your artworks. All artworks will be available to collect unwrapped, so you or your representative are advised to bring any packing material required.

# Frequently asked questions

#### My work involves printmaking and along with other mediums - will it be eligible?

Work involving other mediums is accepted eg. mixed media, collage, hand painting. However, this is a printmaking exhibition therefore the predominant element of the work needs to be printmaking.

#### Is there a size limit for works?

We do not specify a size for works. If you are considering submitting a work which may cause problems in terms of hanging space or logistical issues such as it fitting through the gallery door upon delivery, email <u>info@re-printmakers.com</u> with specific details before you apply. We can confirm whether it is feasible or not for the exhibition if it were selected. Obviously bear in mind that the selectors are aware of the limited space available in the gallery, so entering an etxremely large work may put you at a slight disadvantage to getting your work selected.

#### Do you accept digital prints?

We do absolutely accept digital prints, as long as they are limited edition prints created using digital processes, **not digital reproductions** of another work.

#### Do you accept cyanotypes or photography?

These processes are not strictly 'original printmaking', so as a sole medium, these techniques are not eligible for our competitions. However, these techniques would be accepted when used in combination with printmaking processes

#### I am submitting an artist's book - can I submit more than one image to represent it?

Sorry, our submission system allows only one image per work entered, in cases like this please choose one image that represents the contents of the book for your online submission. State clearly in the medium that it is an artist book and the selectors will take this in to account.

#### What if my work is not suitable to be displayed framed?

We welcome alternative ways of displaying work, however, artists must make provisions for this in that the display method must be suitable for the work and a professional gallery setting. Any additional fixings that will be needed must be provided by the artist and full instructions given for the gallery hanging team.

Artists must be aware that any works not displayed framed, glazed and fitted with mirror plates will not be covered by the gallery insurance and so will be displayed at the artist's own risk.

#### Can I submit work if I live abroad?

Yes! As long as you are willing to arrange transportation of your work to and from the designated delivery and collection locations in London should it be selected. We welcome applications from all artists wherever they are based.

#### Can I enter work on behalf of an artist who is no longer living?

I'm afraid we do not accept submissions from deceased artists, the competition is for contemporary artists only.

#### I'm having trouble with the Zealous system...

Please be aware you first need to make payment for the total number of entries you wish to make, then you will be prompted to add the work image, then details of that work.

# The system is telling me I have entered the maximum number of images allowed when I have uploaded only one, and I have paid for multiple submissions

This message refers to the maximum number of images allowed per submission (ie. per work). Once you upload one image, you will then be asked for the details of that work before uploading your second work image.

#### How do I add multiple submissions?

If you have already paid upfront for multiple submissions, these 'credits' will appear on your Zealous Profile page which you can find by by going to the 'Submissions' tab. The link below shows how to find this: <u>https://app.storylane.io/share/pd3yor6fmwa0</u> If you still have trouble submitting an additional artwork, try refreshing the page or logging out and then back in. Don't worry—anything you've already submitted or started will be saved as a draft.

#### I can't add my address

If your address isn't recognised then you will be given an option to "Create A New Location".
